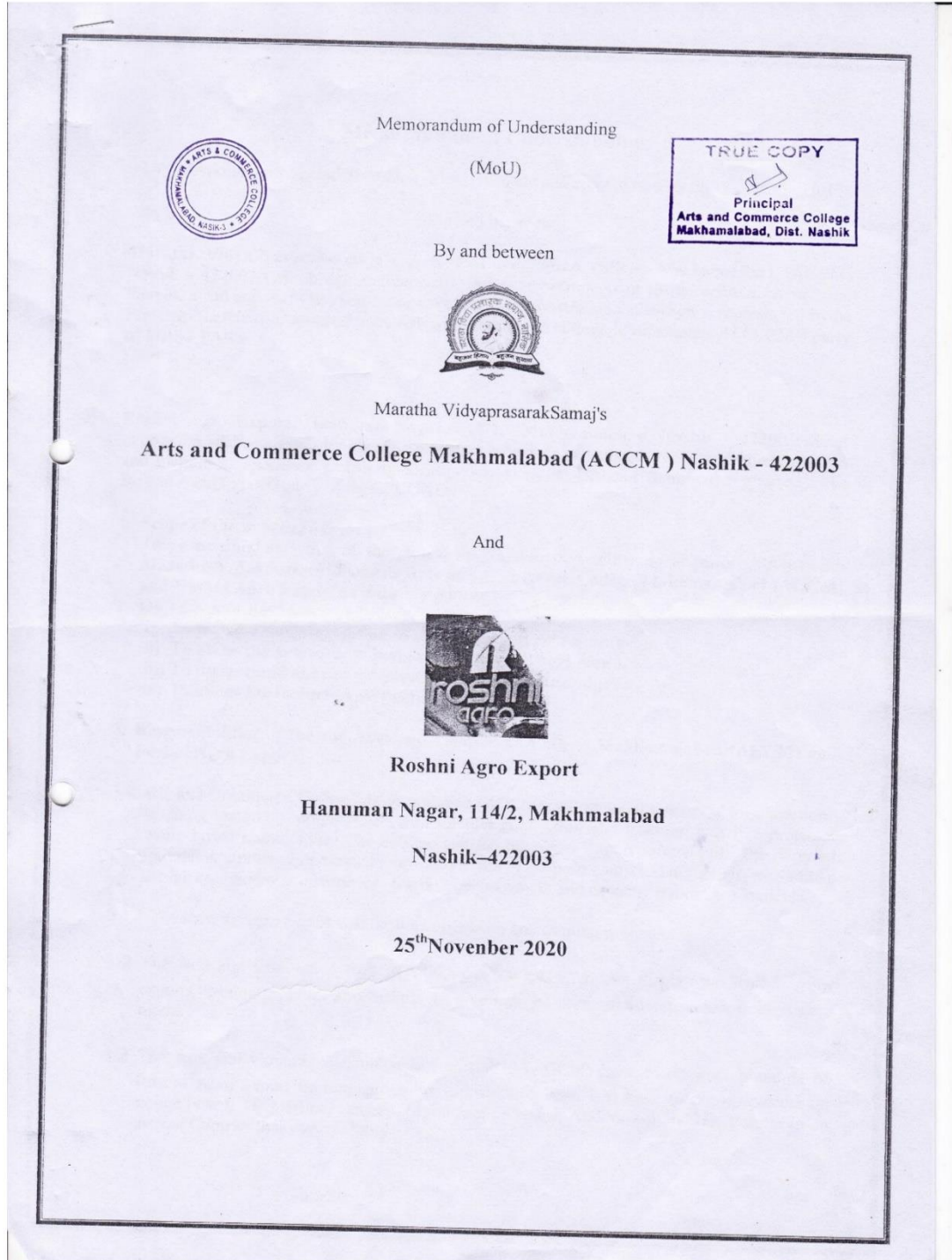

4.2 Effective Date: This MoU is effective from the date of signing by both the parties.





4.3 Validity: This MoU is valid for an initial period of 5 years and may be Renewed for further period with mutual consent of both the parties.
