विषयः प्लॅस्टिक पाणी बॉटल वापरणे बाबत....

वरील विषयान्वये सर्व शाखा प्रमुख यांना कळविण्यात येते की, सध्या प्लास्टिकच्या बॉटलमधील पाणी पिण्याच्या सवयी वाढतच चालल्या आहेत. लांबचा प्रवास किंवा जास्त पाणी पिण्याच्या सवयीमुळे प्लॉस्टिकची बॉटल नेहमी पाहावयास मिळते. मात्र एका संशोधनानुसार प्लास्टिकच्या बॉटलचा प्रयोग करणे आरोग्यासाठी खपच अपायकारक असल्याचे सिध्द झाले आहे. जर आपण नेहमी प्लॉस्टिकच्या बॉटलमध्ये पाणी पित असाल तर आपणास अनेक धोकादायक आजार होऊ शकतात. प्लॉस्टिकच्या बॉटलमध्ये कित्येक हानिकारक केमिकल्स असतात जे गरम झाल्यानंतर पाण्यात मिक्स होतात आणि तेच पाणी पिल्याने पाण्याबरोबर पोटात गेलेल्या हानिकारक केमिकल्समूळे आपल्या शरिराला हानी पोहचते.

महाराष्ट्र शासनाने सदरच्या प्लॉस्टिक वापरास बंदी केलेली असतांनाही आपण सर्रासपणे प्लॉस्टिक पाणी बॉटल, प्लॉस्टिक बॅग वापरत आहोत. परंतु आपल्या हे लक्षात यावयास हवे की. आपणच आपल्या हाताने पर्यावरणावर आघात करून सुष्टिच्या नियमांचे उल्लंघन करत आहोत. तेव्हा आपल्या शाखेतील सर्व शिक्षक, शिक्षकेत्तर कर्मचारी, विद्यार्थी यांना प्लॉस्टिक पाणी बॉटल एैवजी पाणी पिण्यासाठी स्टिलचे/काचेचे ग्लास अथवा तांब्या फुलपात्र वापरणे बंधनकारक करावे.

तसेच संस्थेच्या कोणत्याही कार्यक्रमात स्टेजवर पाहण्यांसाठी प्लॅस्टिक पाणी बॉटल न ठेवता स्टिलच्या ग्लासमध्ये अथवा तांब्या फुलपात्रातच पाणी देण्याचे नियोजन करावे. यापुढे आपल्या शाखेच्या कोणत्याही कार्यक्रमात, कार्यालयात अथवा वर्गात प्लॉस्टिक पाणी बॉटल दिसणार नाही याची दक्षता घेऊन याबाबत सर्वांना सचीत करावे.
